Regulations for granting of scholarships:

1. The scholarships are granted by the Euro-African Foundation for Research, Culture and Education (FORCE) to contribute to the efforts deployed by the State and sundry institutions for the development of academic excellence and the lifting of financial barriers that can impede particularly gifted students or researchers in achieving of their study or research projects.

There are two types of scholarship:

- * **Excellence scholarships (BE) :** Granted on study level criteria on personal motivation and scope of professional project submitted by the applicant.
- * **Social scholarships (BS) :** Granted as per the aforementioned criteria in addition to the financial situation of the applicant.

2. **Application submittal procedure:**

- * **The applicant must first proceed to preliminary registration.**
- * **The applicant must fill out this form specifying the type of scholarship applied for and the registration center selected in the Group.**
- * **The dossier must include:**
 - . A motivation letter spelling out the profile, the study path and professional project
 - . Certified copy of the national identify card or passport
 - . 3 recent photos
 - . Certified copy of most recent diploma(s) obtained
 - . Certified copy of the transcripts of the last year of studies
 - . Notarized declaration upon honor testifying to the validity of the information provided (Model ATH)
 - . Certified declaration of income (Model ATR), for social scholarships only.

3. **The dossier must be submitted by email, fax or postsent to the Group Headquarters by October 1.**
4. **The jury consisting of the Foundation members and associate members examine the applicants received and correctly filled out along with all the requisite documents.**
The selection is carried out in compliance with the criteria specified in (1) and the decisions made are communicated to the relevant parties by mail during the month of October.
5. **If the Foundation discovers a discrepancy in the information given in the information about the application or if the Registration Center of the applicant advises the Fondation on a serious misrepresentation by the applicant detrimental to the image of the said center or to the internal regulations thereof the Foundation reserves the right to cancel the Scholarship granted.**
